Code of Conduct

Participants registered for Stillwood Camp Programs must agree to abide by the guidelines set forth by Stillwood Camp. Participants live as part of a community during their stay at camp; as such their interaction with others, including Stillwood Camp staff members needs to be respectful and considerate at all times. All activities (on and off camp property) will be led by trained Stillwood staff. We ask that all registrants adhere to the guidelines set out by these staff members. These include but are not limited to: coarse language, hurtful or demeaning comments, argumentative behavior, disregard for rules, etc. Failure to comply with Stillwood Camp's Code of Conduct may result in exclusion from the remainder of the participant's stay. This will be at the discretion of the Program Director and/or Executive Director. In addition, speaker led sessions, are an important component to our Family Camp program and are not optional. Any questions about, or exceptions to, the Code of Conduct need to be discussed and established BEFORE family arrival.

Consent and Statement of Liability

The purpose of this section is to ensure that family members and particularly persons under the age of 19 have permission from their parent or legal guardian to participate in the various Stillwood Camp programs. It is also designed to provide some information regarding the hazards and risks that are present when these programs are conducted, in order to help parents make informed decisions regarding their child or family participation.

The activities available during Family Camp are conducted by Stillwood staff. Since 1958, we have been providing quality outdoor programs to thousands of adults and children. Our guides and instructors have been selected for their experience in the outdoors and ability to provide each participant with an outstanding experience in a natural setting. Our attention to detail in risk management and staff training contribute to our excellent safety record. Our program and activities will be conducted rain or shine. It is important that participants dress appropriately and be prepared for any weather. Please be advised to bring rain gear, warm layers, a hat, sun screen, a swimsuit, and any medication that your family members may need. Immersion in water is a possibility. Please include a complete change of clothes including shoes and socks.

Whenever these types of outdoor activities are conducted, there are natural hazards and risks. In addition to the usual risks, dangers and hazards can present themselves in outdoor activities and programs and may involve additional risks such as:

- Changing weather conditions such as wet or slippery conditions that may result in falls.
- Climbing on steep or vertical slopes that may result in falls or falling rock.
- Immersion in water that may result in hypothermia or drowning.
- Travel through forest environments which may result in injury from trees, branches, sticks, etc.

"I am sure that the Stillwood Camp staff will do their best to give me and my family the necessary support and supervision needed and I understand that safety and health rules will be observed. I hereby give camp personnel the authority to act on my behalf in case of an emergency, including medical treatment (parent/guardian will be notified as soon as possible). I understand that I am financially responsible. When the camp program involves leaving the camp premises (e.g. waterfront, hiking, etc.), I give permission for me and my family to participate. I hereby release Stillwood Camp and its personnel from all claims for damages arising from any accidents or injury caused by me and my family's participation in the camp program. Myself and my family's photo may be used in Stillwood media and publications. I am aware of, and understand the risks, dangers, and hazards associated with these programs.
